The Motel was recently sold and the new owners have advised that they will no longer provide TA to those at risk of homelessness;
- 4. The Council resolves to write to Trish Doyle MP, Member for Blue Mountains, seeking her urgent assistance to advocate to the NSW Minister for Housing regarding current and future provision of TA in the Upper Blue Mountains; and
